- 5. Approval of Catholic School Council Minutes June 12, 2024 Motion by Jenna Shugg, Second by Marianne Krzal. Motion Carried.
- a. Business Arising from the June 2024 Minutes; Soccer remains removed from certain classes. Soccer has been banned by certain school classrooms due to aggressive behaviour, and serious injuries sustained. When they provide a code of conduct and sign the list. If someone breaks the Catholic Code of Conduct, they lose the privilege to play soccer on the field at recess. Student safety is paramount.

- 1. **Chair/Treasurer's Report** Final Annual. Some outstanding items remain. \$4600 in the bank however there remains one more pizza day from 2023-2024 school year to be paid for and funfair pizza. Tracy is looking into this.

Woodward Meats cheque was not yet deposited. Cheque received in June.

Total revenue 2023/2024 \$67520; not include cash from pizza from the last 3 months of school.

Expenses \$65700

Total Balance \$3790. \$1500 of this is promised to the open house BBQ.

Action Item: Melissa to connect with Tracy to see if cheque is in the school and if not ask Woodward to reissue.

- **2. Principal Report** Welcome to Mrs. Cameron as VP. Welcome back to Ms. VanStokum. Sacramental and School Mass dates have been set tentatively. Opening mass is October 4, 2024. As dates become finalized, they will be shared with families in the Sizzler.
- Wellbeing conference September 19, 2024.
- A new water fountain and a basketball net in the junior's yard has been purchased and installed over the summer. Total cost was approximately \$7000.
- FDK sensory pathway to be developed this year. School is looking for input for addition to enrich outdoor space for primary grades.
- Code of Conduct Assembly for intermediate students took place September 18. Assembly for younger students in the coming days. New dress code was addressed in the assembly.
- New PPM 128 Anti-Vaping and Personal Electronic Devices (PED) policies have been put in place from the Ministry. This includes wearable devices. It must be out of sight, off or on silent and in backpacks during the school day. Vape detectors have been installed in the bathrooms in elementary and secondary schools. This PPM mandates consequences for students.
- DPCDSB policy on progressive discipline is being updated. This outlines what progressive discipline steps are required.
- This is the year of the Jubilee. Classes are being encouraged to incorporate this in their classroom prayers once a week.
- Share Life Spirit Week and Food Bank Donations. St. Francis is hoping to raise a bit more money for these causes.
- Terry Fox Run is set for September 27th.
- Truth and Reconciliation week is Sept 24-27th. September 30th is Orange Shirt Day.
- Progress Reports being sent home November 12
- Empower and Lexia Program licences to be renewed. The school has less licences this year than last.
- High Impact Strategies in Math and UFly and Haggerty are programs being used in the classroom.
- Enrollment is 431 for 2024-2025 school year as of September 18th 2024. Primary grades are capped at 20. Re-organization has been completed.
- Grade 7 and 8 have received their Edwin devices

- School Generated Funds are over \$11000 for 2024-2025. This number will drop due to the cost of the basketball net and water fountain that were installed over the summer.
- Kiss and Ride Rules are there to ensure safety of all students and staff. Please be diligent and follow staff instructions.
- Picture Day is September 26, Re-take Day is November 7
- Lunch options are coming back soon. Lunch Box is available on School Cash Online
- Pizza Day is returning. Date TBD
- Lunch Monitors are desperately needed at St. Francis of Assisi. Vulnerable Sector Check needs to update to be a student monitor. Right now, the wait through Peel Police is approximately 6-8 weeks. Those interested that need a letter from the principal for the police station can email the SFA info box for the letter of support.
